

Petition Affidavit and License -
W. H. L. Lee et al. for Wharf.

To the Hon. Board of Municipal Officers
of the Town of Eden, Hancock County -
State of Maine.

The undersigned, William H. L. Lee of the
city of New York, owner of the fee of the landing
hereinafter described, in behalf of himself and
others having rights and easements in said
landing respectfully represents that he together
with other persons having rights and easements
in said landing intend to maintain the wharf
now existing in front of said landing and to
build and extend said wharf into these waters
within the limits of the town of Eden.

Wherefore the undersigned prays your Honorable
Board to grant a license for the maintenance
of the present wharf and for the building,
extension and maintenance of a wharf in
tide waters in the town of Eden, within the
following location, limits and boundaries, to wit:

Situated at Hulls Cove in said Town of
Eden in front of a certain lot of land four rods
square adjacent to the shore at said Hulls
Cove and lying at the terminus of a way twenty-
five feet wide. Being the lot of land
marked "Landing" upon a certain map of
land at Hulls Cove Point belonging to William
H. L. Lee and others, Nov. 1883, laid out by
Jos. H. Curtis, Landscape Engineer, Boston, from
surveys made by Eben M. Hamor, Eden
said landing being marked by stone posts at
the corners thereof and being situated between
lot No. 3, on said map owned now or formerly
by Guy Fairfax Whiting and lot No. 4, owned or occupied
by Elneline F. Parsons.

The undersigned, Municipal Officers of the town of Eden, Hancock County, State of Maine, having received a written application signed by William H. L. Lee hereinafter annexed and having given at least three days public notice thereof as provided by law, said notices having been given at the time and in the manner specified in the above affidavit met at the time and place appointed in said notice to wit, on the landing described in said application on Monday the fourth day of October 1897 at ten o'clock in the forenoon, said place being near and immediately adjacent to the premises described and we then and there examined the premises, heard the Petitioner who was present by counsel and heard all parties interested who were present.

Upon such application and hearing we decided and do decide that the maintenance of the existing wharf and the erection of a wharf as hereinafter described will not be an obstruction to navigation nor an injury to the rights of others, and we have determined and do determine to allow the same and to issue a license under our hands to the said William H.
