To the Honorable Senate and House of Representatives in Legislature assembled:-

Resolved: That as building operations and employment in general in Bar Harbor, are now practically at a standstill and a large number of workmen and their families are actually suffering on account thereof; and as a large amount of building will be begun immediately following the repeal of the automobile exclusion laws, and as a general law without an emergency clause will not go into effect until sixty days after the adjournment of the Legislature; we, the legal voters of the town of Eden, in town meeting assembled, respectfully request that an emergency clause be attached to any automobile legislation which may be passed at this session.
