Warrant for Special State Election

To Fred. H. Gerry, Constable of the Town of Edw, Maine:

You are hereby required in the name of the State of Maine, to notify and warn the inhabitants of said Town of Edw, qualified according to law, to assemble at the Larino so called, on the eighth day of September, nineteen hundred and thirteen, at ten o'clock in the forenoon, to give in their votes for a Representative to Congress of the United States, to fill the vacancy now existing by the death of Honorable Forest Goodwin, member from the Third District; also to give in their votes on the following questions:

Question I.

Shall the Constitution be amended as proposed by a resolution of the Legislature providing for the classification of property for purposes of taxation?

It has been proposed, by a resolution of the Legislature that section eight of article nine of the constitution be amended so that it will read as follows:

Section 8.

All taxes upon real and personal estate assessed by authority of this state, shall be apportioned and assessed equally, according to the just value thereof; but the Legislature shall have power to levy a tax upon intangible property at such rate as it deems wise and equitable without regard to the rate applied to other classes of property.

Those in favor of this amendment will place a cross in the square marked yes.

Those opposed will place a cross in the square marked No.

Question II.

Shall the Constitution be amended as proposed by a resolution of the Legislature permitting amendments to the Constitution to be voted upon at regular elections?

It has also been proposed to amend section two of article ten of the constitution so that it will read as follows:

Section 2.

The Legislature, whenever two-thirds of both houses shall deem it necessary, may propose amendments to this Constitution; and, when any amendments shall be so agreed upon, a resolution shall be passed and sent to the selectmen of the several towns, and the assessors of the several plantations, empowering and directing them to notify the inhabitants of their respective towns and plantations in the manner prescribed by law at the next biennial meetings in the month of September or to meet in the manner prescribed by law for calling and holding biennial meetings of said inhabitants

for the election of senators and representatives, on the second Monday in September following the passage of said resolve, to give in their votes on the question, whether such amendments shall be made; and if it shall appear that a majority of the inhabitants voting on the question are in favor of such amendments, shall become a part of this Constitution.

Those in favor of this amendment will place a cross in the square marked Yes.

Those opposed will place a cross in the square marked No.  
The polls will be opened at ten o'clock in the forenoon, and be closed at five o'clock in the afternoon.

The Selectmen will be in session at their office on the fourth, fifth, and sixth days of September from ten o'clock in the forenoon until five o'clock in the afternoon, for the purpose of correcting the list of voters.
