



## Warrant Annual Town Meeting

To Fred H. Gerry, a constable of the Town of Eden,

Greeting:

In the name of the State of Maine, you are hereby required, to notify and warn the inhabitants of the town of Eden, qualified by law to vote in town affairs to meet at the Casino in Bar Harbor, in said town, on Monday, the second day of March, A. D. 1914, at ten o'clock a.m. to act on the following articles, to wit:

Article 1.

To choose a Moderator to preside at said meeting.

Article 2.

To choose a Town Clerk for the ensuing year.

Article 3.

To choose three Selectmen, one Assessor, Town Treasurer, Collector of Taxes, Overseer of Poor, Road Commissioner, for 1 year, Road Commissioner, for 2 years, Road Commissioner, for 3 years, two members of the Superintending School Committee, Agent of Town School Fund, Auditor and Chief of Fire Department, in accordance with Chapter 215 of the Special Laws of 1913.

Article 4.

To choose all other necessary town officers.

Article 5.

To hear the report of Town Officers and Committees and act thereon.

Article 6.

To see if the town will vote how the taxes shall be collected for the ensuing year.

Article 7.

To see if the town will vote when taxes shall be due, what interest shall be charged, if any, and for what time.

Article 8.

To see if the town will fix the compensation of the Superintending School Committee.

Article 9.

To see if the town will fix the compensation of the Treasurer and Collector.

Article 10.

To raise money to defray town charges.

Article 11.

To raise money to pay principal on town bonds and notes.

Article 12.

To raise money to pay interest

Article 13.

To raise money for support of poor.

Article 14.

To raise money for common schools.

Article 15.

To raise money for Free High school.

To raise money for text books and supplies.

To raise money for sidewalks at Bulls Cove.

To see if the town will vote to macadamize School street from Mount Desert street to Pleasant street and raise a sum of money for same.

Article 39.

To see if the town will vote "yes" or "no" on the question of appropriating and raising money necessary to entitle the town to state aid, as provided in section 20 of chapter 130 of the Public Laws of 1913.

Article 40.

To see if the town will appropriate and raise an amount not exceeding the sum of \$9325.00 for the improvement of the section of state aid road as outlined in the report of the state highway commission, in addition to the amounts regularly raised for the care of ways, highways and bridges; the above amount being five times the maximum which the town is allowed to raise for one year, as provided in section 22 of chapter 130 of the Public Laws of 1913.

Article 41.

To see if the town will appropriate and raise the sum of \$1865 for the improvement of the section of state aid road as outlined in the report of the state highway commission, in addition to the amounts regularly raised for the care of ways, highways and bridges; the above amount being the maximum which the town is allowed to raise under the provisions of section 19 of chapter 130 of the Public Laws of 1913.

Article 42.

To see what action the town will take in reference to the use of the High school building on High street as offices for the town officers, and raise a sum of money for same.

Article 43.

To see if the town will improve the drain on the eastern side of Main street between the Florence Hotel and Hancock street, and raise a sum of money for same.

Article 44.

To see if the town will vote to construct permanent roads in the eastern part of the town and raise a sum of money for the same.

Article 45.

To see if the town will vote to raise a sum of money to repair roads and bridges in the eastern part of the town.

Article 46.

To see if the town will vote to raise a sum of money for the repair of sidewalks at Bar Harbor.

Article 47.

To see if the town will vote to raise a sum of money for cleaning streets.

Article 48.

To see if the town will vote to raise a sum of money for sprinkling streets.

Article 49.

To see if the town will vote to purchase road oil for sprinkling streets and raise a sum of money for the same.

Article 50.

To see if the town will vote to raise a sum of money for the repairs of sewers.

Article 51.

To see if the town will vote to raise a sum of money for the disposal of garbage.

Article 52.

To see if the town will vote to raise a sum of money for the Joseph Memorial Library, and appoint a committee to act with the library in the expenditure of the same.

Article 53.

To see if the town will vote to raise a sum of money for the services and expenses of the Board of Health.

Article 54.

To see if the town will vote to resurface Cottage Street from the Post Office to Eden Street and raise a sum of money for same.

Article 55.

To see if the town will vote and authorize the Selectmen to make a temporary loan in anticipation of taxes of 1914.

Article 56.

To see if the town will authorize and instruct the Selectmen to negotiate for the sale and transfer of any property or properties for which it holds tax deeds and to execute the proper release or transfer of same.

Article 57.

To see if the town will vote to fix the compensation of the municipal officers.

Article 58.

To see if the town will vote to raise a sum of money to pay for services of a District Nurse.

Article 59.

To see if the town will vote to raise a sum of money to keep the public horse shed in a sanitary condition, said money to be expended by the Board of Health, and Selectmen.

Article 60.

To see if the town will vote to authorize the Selectmen to employ one or more police officers to be known as Harbor Police with special reference to the enforcement of the law requiring motor boats to use mufflers in accordance with the State law, such employment to be made with or without a motor boat as deemed best, and to raise a sum of money for the same.

Article 61.

To see if the town will vote to repair the steam roller and raise a sum of money for the same.

Article 62.

To see if the town will vote to repair the sewer on Oak street and raise a sum of money for the same.

Article 63.

To see if the town will vote to install a light on Oak street and raise a sum of money for the same.

Article 64.

To see if the town will vote to install a hydrant at Bulls Cove, and raise a sum of money for the same.

Article 65.

To see if the town will vote to raise a sum of money to pay the clerk hire for the Superintendent of Schools.

Article 66.

To see if the town will vote to fence the isolated hospital lot and improve the grounds around same.

To see if the town will vote to authorize the Selectmen and Board of Health to contract for the disposal of garbage for a term of years.

Article 68.

To see if the town will vote to widen and improve Eden street from the Bassall property to the property of A. B. Turner, and raise a sum of money for the same.

To see if the town will vote to raise the sum of two thousand dollars to be expended on the Indian Point road leading from Town Hill to Deep Brook.

To see if the town will vote to reimburse R. Hall, M<sup>r</sup>. McCormick for money expended by him in constructing the public sewer on Central avenue and to raise money for same.

Article 74

To see if the town will vote to install a light on Hancock street near property of John Stafford.

Article 75

Under the authority of Chapter 102 of the Public Laws of Maine for the year 1913, to see if the town will vote to raise a sum of money and contribute the same towards the cost of construction of the bridge across Otter Creek, recently erected by the Otter Creek Bridge Co.

Article 76

To see if the town will vote to accept the return of the Selectmen, laying out a town way from the town way leading from Otter Creek to the Ocean Drive to the center line of the easterly end of the bridge now built across the waters of Otter Creek.

Article 77

To see if the town will vote to finish the sidewalk on the west side of School street from the Methodist Church up to Mount Desert street and raise a sum of money for the same.

Article 78

To see if the town will vote to repair the bridge on Eagle Lake road near Forest street and raise a sum of money for same.

Article 79

To see if the town will vote to purchase the Mount Desert Toll bridge, for the purpose of making it a free bridge, as provided by act of the Legislature of Maine for the year 1836, Chapter 7. Such purchase to be made jointly with any other town or towns having similar interests under said act.

Article 80

To see if the town will appoint a committee with power to carry the above vote into effect.

Article 81

To see if the town will authorize its selectmen to hire on the credit of the town such sum of money as may be necessary to purchase the Mount Desert bridge jointly with other town or towns, and to issue the town's negotiable notes therefor.

Article 82.

To see if the town will vote to pass an ordinance regulating the width of tires on all heavy vehicles drawn by horses.

Article 83.

To see if the town will vote to accept the provisions of Chapter 188 of the Private and Special Laws of 1913, entitled, "An Act to change the name of the Town of Eden to the Town of Bar Harbor."

Article 84.

To see if the town will vote to construct the road leading from the foot of School Street to Hedgebawn Avenue extension, and raise a sum of money for same.

Article 85.

To see if the town will vote to raise a sum of money to clear out the bed of Cromwell's Harbor Brook from a point below Main Street to such point above as will prevent flooding of the house lots and cultivated land lying to the south of Cromwell's Harbor road, and use the material from the brook bed in constructing the road in the preceding article.

Article 86.

To see if the town will vote to appropriate the sum of three hundred and fifty dollars for spraying shade trees along the streets of Bar Harbor Village.

Article 87.

To see if the town will vote to purchase one thousand feet of hose for the Fire department and raise a sum of money for the same.

Article 88.

To see if the town will vote to repair the Harder Farm road and raise a sum of money for the same.

Article 89.

To see if the town will vote to construct a surface drain on Waldon road and raise a sum of money for the same.

Article 90.

To see if the town will vote to construct a surface drain on Pleasant Street and raise a sum of money for the same.

Article 91.

To see if the town will vote to oil the roads in the western part of the town and raise a sum of money for the same.

Article 92.

To see if the town will vote to accept a town way as laid out by the Selectmen and known as Billings Avenue, and raise a sum of money for the same.

Article 93.

To see if the town will vote to elect by written ballot the Chief of Police for said town, for the ensuing year.

Article 94

To see if the town will vote to establish rates for public carriage fares, and require all vehicles to be numbered and to carry a price list.

Article 95

To see if the town will vote to make any change in the by-laws in regard to street traffic or rules for driving.

Article 96

To see if the town will vote to appoint a committee to investigate the advisability of installing a municipal lighting plant, to make plans and obtain estimates on same, and to raise a sum of money to be expended by said committee.

Article 97

To see if the town will vote to construct a sidewalk on the Eagle Lake road from Mrs. Harrison's to Forest street and raise a sum of money for the same.

Article 98

To see what action the town will take in regard to providing some place to be used as a town farm almshouse, or house of correction, and authorize the Selectmen and Overseer of the Poor to contract with some person as master of such farm, and raise a sum of money for the same.

Article 99

To see what action the town will take to improve its lot on the shore path, and raise a sum of money for the same.

Article 100

To see if the town will vote to continue the sidewalk on the Indian Point road from where it now ends to the Wright estate, and raise a sum of money for the same.

Article 101

To see if the town will vote to raise the sum of one hundred dollars to repair the town way leading from the main road from West Eden to Indian Point to the shore near land of C. H. Stover and Samuel Leland.

And that no names will be received later than five o'clock in the afternoon of the regular day next preceding the day of election and that no names will be received on the day of election except such as were upon the list of the previous election and have been inadvertently omitted by the Selectmen.

## Record of the Annual Meeting.

Pursuant to the foregoing warrant, the legal voters of the town of Eden, assembled in the Casino, in Bar Harbor in said Eden, and on Monday, the second day of March, A. D. 1914, and proceeded to act on the articles in the warrant as follows:

The meeting was called to order at 10 A. M. by W. H. Sherman, Town Clerk, who read the warrant and the constables return thereon

Article I - To choose a Moderator.

Horatio H. Wakefield was unanimously elected Moderator and was sworn by the Town Clerk.

Article 2 - W. H. Sherman was unanimously elected Town Clerk and was sworn by the Moderator.

Article 3 - To choose all officers to be elected by ballot as provided by Chapter 215 of the Special Laws of 1913.

The Moderator read the following order, and the within named Ballot clerks were sworn by the town clerk, with the exception of W. L. Pierce, who was not present:

By virtue of the authority vested in us under section 13 of Chapter 215 of the Public and Special Laws of 1913 we the Municipal Officers of said Town do appoint Irving F. Hodgkins, B. E. Whitney, George F. Terry, W. L. Pierce, Irving Hamor, A. J. Babbridge, and Fred B. Hayes, as ballot clerks for the Annual Town Meeting.

Voted: That the town officers take such action as they may deem necessary to maintain the town's rights the whole width of the road.

Article 71.

Voted: To raise \$600 to construct a sidewalk on Myrtle Avenue.

Article 72.

Voted: To indefinitely postpone.

Voted: To indefinitely postpone.

Article 74.

Voted: To indefinitely postpone.
