Pineo it was voted, That the electric light committee appointed at the last annual town meeting be and hereby are instructed to place before the Public Utilities Commission all facts in relation to the prices charged for electric lights in Eden, by the Bar Harbor and Union River Power Co., and that said committee use all reasonable means to secure a reduction in the price of municipal and private lighting and that the balance of the fund appropriated to defray the expenses of the Committee be available for the above purpose.

Permit to Construct and Maintain Poles and Wires.

To the Selectmen of the town of Eden, Hancock County, State of Maine:

The Bar Harbor and Union River Power Company, a corporation organized and existing under the laws of the State of Maine and doing business at Bar Harbor and other places in said State, hereby makes application for a written permit and an alteration of a written permit, under Revised Statutes of the State of Maine, Chapter 55, Section 17, and represents; That it has a line of poles and wires for the transmission of light and power along the Gilbert Farm Road, so called, in said town of Eden, for the construction and maintenance of which it has previously applied for and obtained from the Selectmen of the said town of Eden, the written permit therefor authorized by said Chapter 55 of the Revised Statutes; that your Honorable Board has directed an alteration in such original permit as to the location of one of its poles on said Gilbert Farm Road, namely, the pole situated on the southerly side of said Gilbert Farm Road, near the intersection of said Gilbert Farm Road with the road leading from Knox District to West Eden, being pole numbered 528, and such removal being immediately necessary, owing to repairs and alterations of the road, said corporation has removed said pole, together with wires and fixtures. Said corporation now respectfully prays that such original permit may be altered in respect to said pole and that a written permit may be issued authorizing the construction and maintenance of one pole and wires and fixtures connected, in the same position where pole numbered as above set forth now stands along and near the northerly side of the Gilbert Farm Road in said Eden, near the intersection of said Gilbert Farm Road with the road leading from Knox District to West Eden. Said Corporation also prays that, as required by said statute, you will, in your permit, specify the kind of pole, the height of wires above the ground and other particulars required by said Section 17 of Chapter 55 of the Revised Statutes.

Meeting called to order at 10 a.m. by Town Clerk, W. H. Sherman.

Call for Meeting and Officer's Return read by the Town Clerk.

 Roy Hamor was declared elected.

Article 4. To choose all other necessary town officers.

Voted: To indefinitely postpone.

Article 5. Report of Town Officers and Committees.

Voted: To accept the report of Town Officers and Committees.

Article 6. How taxes should be collected.

Voted: That the taxes of 1915 when assessed, shall be committed to the Treasurer and Collector for payment to him, and that all personal property taxes and poll taxes not paid to the Treasurer and Collector June 1, 1916 be given to an officer for collection.

Article 7. When taxes shall be due, what interest etc.

Voted: That the taxes of 1915, be due and payable September 1, 1915, and that on all taxes unpaid September 1, 1915 interest shall be charged at the rate of 6% from September 1, to date of payment.

Article 8. Money for Superintendent of Schools.

Voted: To raise \$350 for the Superintendent of Schools.

Article 9. Compensation of Treasurer and Collector of Taxes.

Voted: That the salary of the Treasurer and Collector of Taxes be fixed at \$200 in full payment for his services for acting as said town Treasurer and collecting taxes.

Article 10. Town Charges.

Voted: To raise \$7,000 to defray town charges.

Article 11. Town bonds and notes.

Voted: To raise \$2,500 to pay maturing bonds.

Voted: That the Selectmen be and hereby are authorized to issue the town's negotiable bonds in the sum of \$5,500 to refund the town's notes now outstanding, such bonds to mature in the year 1925, and to be denominated "Town of Cedar, Funding Bonds" and to draw interest not exceeding four per cent. (4%).

Voted: To raise \$1,800 for text books and supplies.

Article 17. Repair school property.

Voted: To raise \$2,000 to repair school property.

Article 18. Manual training, domestic science.

Voted: To raise \$1,000 for manual training and domestic science.

Article 19. Medical examination in schools.

Voted: To raise \$100 to pay a physician for medical examination in our schools.

Article 20. Band Concerts.

Voted: To raise \$500 to pay for a series of band concerts.

article 21 Fire Department

Voted: To raise \$,500 for the support of the Fire Department.

article 22 Roads and bridges

Voted: To raise \$16,000 for the repair of roads and bridges.

article 23 Sidewalks

Voted: To raise \$3,000 to repair sidewalks.

article 24 Oiling and sprinkling streets

Voted: To raise \$10,000 for oiling and sprinkling streets.

article 25 Repair Main street, Newton Way to Cromwells Harbor bridge.

Voted: To indefinitely postpone.

Voted: To reconsider and raise \$4,500 to repair main street from Newton Way to Cromwells Harbor bridge.

article 26 Repair Otter Creek road.

Voted: To raise \$1,500 to repair the Otter Creek road.

article 27 Reconstruct Houll's Cove bridge.

Voted: To indefinitely postpone.

article 28 Widen Eagle Lake road

Voted: To indefinitely postpone.

article 29 Lighting streets

Voted: To raise \$6,000 for lighting streets.

article 30 Water for fire and municipal purposes.

Voted: To raise \$4,025 for water for fire and municipal purposes.

article 31 Brown tail moths.

Voted: To raise \$300 for the extermination of the brown tail moth.

article 32 Eden Agricultural Society.

Voted: To raise \$200 for the Eden Agricultural Society.

article 33 Kindergarten

Voted: To raise \$250 for the kindergarten.

article 34 Memorial Day.

Voted: To raise \$750 for Memorial Day.

article 35 Reconstruct sewer, Cottage St near Oak St near L. B. Deary's line.

Voted: To raise \$600 to reconstruct the sewer as described in art. 35.

article 36 "Yes" or "No" on raising money to entitle town to State aid.

Voted: To indefinitely postpone.

Voted: To reconsider.

Voted: That the town vote "yes" on this question.

article 37 Improvement of State aid road.

Voted: To indefinitely postpone.

Voted: To reconsider.

Voted: To raise \$1,732 for the State aid road as described in art. 37.

article 38 Relay Arcadia landing sewer.

Voted: To raise \$400 to relay the Arcadia landing sewer.

article 39 Repair of sewers.

Voted: To raise \$2,000 for the repair of sewers.

article 40 Repair Cromwell Harbor road.

Voted: To raise \$300 to repair Cromwell Harbor road from Main St. to Hedgecote Ave.

Article 41 Repair permanent roads.

Voted: To raise 4,000 to repair the permanent roads.

Article 42 Cleaning streets

Voted: To raise 1,800 to clean streets

Article 43 Repair Eagle Lake road.

Voted: To indefinitely postpone.

Voted: To reconsider.

Voted: That wherever in the town of Eden private proprietors have fences, buildings, hedges or other structures, encroaching upon the limits of public ways, the selectmen are hereby authorized and instructed to have such obstructions removed or to take such action as may be necessary to prevent the loss of any rights by the town.

Article 44 Crushing stone

Voted: To raise 3,300 for crushing stone.

Article 45 Surface draining.

Voted: To raise 2,500 for surface drainage.

Article 46 Steam roller.

Voted: To indefinitely postpone.

Article 47 Disposal of garbage.

Voted: To raise 2,650 for the disposal of garbage.

Article 48 Jerup Memorial Library.

Voted: To raise 300 and that the same be placed with the Trustees of Library.

Article 49 Board of Health.

Voted: To raise 2,000 for the services and expenses of the Board of Health.

Article 50 Widening Park street.

Voted: To accept the widening of Park street as laid out by the Selectmen.

Article 51 Authorize Selectmen to sell and transfer property for tax deeds.

Voted: That the Selectmen be given the authority as specified in art. 51.

Article 52 Public Horse Shed.

Voted: That the horse shed be kept in a sanitary condition and that the cost be taken from the general street cleaning fund.

Article 53 Harbor Police

Voted: To indefinitely postpone.

Article 54 Change in road near Killbidge's farm.

Voted: To indefinitely postpone.

Article 55 Trenton toll bridge.

Voted: To indefinitely postpone.

Article 56 Exchange land with Geo. H. Preble.

Voted: To indefinitely postpone.

Article 57 Contract for disposal of garbage

Voted: To indefinitely postpone.

Article 58 Reimburse W. M. Roberts.

Voted: To raise 25 to reimburse W. M. Roberts for money paid, as described in art. 5

Article 59 Complete road from Burns corner, etc.

Voted: To raise 200 to complete the road from Burns corner to State aid road.

Article 60 Reconstruct sidewalk on High street

Voted: To indefinitely postpone.

Article 61. Widening of ash street

Voted: That the town accept the widening of ash street as laid out by the selectmen.

Article 62. Street vendors license.

Voted: That all street vendors of frankfurts, fruit and ice cream be required to have a license from the selectmen.

Article 63. Compensation of officers.

Voted: That the town pay its assessors \$3 a day for actual time employed.

Voted: That the town pay its selectmen not more than \$5 each and that the selectmen be authorized to hire a book-keeper and such other assistants as they deem necessary, salaries to be fixed by the selectmen.

Article 64. Reimburse Mrs. O. W. Young.

Voted: That the town reimburse Mrs. O. W. Young amount paid physician for injuries sustained on the sidewalk.

Article 65. Reimburse F. J. Nash.

Voted: To pay F. J. Nash \$50 for damage done to mushroom beds on account of sewer.

Article 66. Hedgeman ave. extension sewer.

Voted: To raise \$150 to continue the Hedgeman Avenue Extension sewer from a point near George Tracy's house to a point near Joseph Snell's house.

Article 67. Town engineer.

Voted: To indefinitely postpone.

Article 68. Bar Harbor Athletic Field.

Voted: That the town lease the Bar Harbor Athletic Field for the term of twenty years from the twenty-second day of September, 1914; that the leases presented and read at this meeting be approved and that the Municipal Officers be and hereby are authorized and instructed to execute the same in behalf of the Town.

Under this article, Mr. A. H. Lynam, who represented the trustees (lessors) stated that it was the intention of the trustees to convey the leased property to the town, at the end of the twenty years specified in the lease.

Article 69. Sewer from Park street.

Voted: To raise \$68.75 to reconstruct the sewer from Park St. on Cromwell Harbor road.

Article 70. Reimburse Eben Parsons.

Voted: To raise \$98 to reimburse Eben Parsons for injuries received while working on a drain on Holland avenue in 1914.

Voted: To indefinitely postpone.

Article 72. Laying out and bounding town ways.

Voted: That on all roads where \$500 per mile or more is expended in 1915 such roads shall be laid out, bounded, plans made and placed on file.

Article 73. House on Grant lot.

Voted: That the selectmen be authorized to let the house on the Grant lot.

Article 74. Widening of Spring street.

Voted: To accept the widening of Spring street as laid out by the selectmen.

Article 75. Spraying trees.

Voted: To raise \$50 for spraying trees in the village of Bar Harbor.

Article 76 Purchase fire hose.

Voted: To raise \$50 to purchase 1,000 feet of fire hose.

Article 77 Change in the laying out of a road.

Voted: To accept the report and that \$300 be raised for purpose described in art. 77.

Article 78 Surface drain on Pleasant street.

Voted: To indefinitely postpone.

Article 79 Allow Capt. W. W. Hunt twenty-five dollars in labor etc.

Voted: That the town allow Capt. W. W. Hunt twenty-five dollars in labor to be expended on the road leading from the Indian Point road to Hunt Property.

Article 80 Ireland Lodge proposed new building for municipal offices

Voted: That the Town lease from Ireland Lodge, I. O. O. F. No 126 a portion of its proposed new building on Cottage street for Municipal Offices for a term of ten years, at a yearly rental of One Thousand, One Hundred Dollars (\$1,100.00); Provided that said rooms etc., contain not less than 4,000 square feet of floor space, and said offices to contain a fire proof, reinforced concrete vault, not less than 10 ft. by 10 ft. square, and 10 ft. high, inside measure; to be finished smooth white surface inside and fitted with light unglazed-tile floor and to have fire proof vestibule doors complete; all built and paid for by the lodge; the floors throughout to be of good quality of hard wood, matched and blind nailed, scraped clean and finished with two coats of paraffine oil; that inside finish, mop boards, chair and picture rails, doors etc., be N. C. pine, finished natural bright, two coat work; all doors to have one large glass panel in upper half and all doors to have transom sash over top hinged for ventilation and light; plaster to be smooth finish, ceilings tinted two coat work and walls painted three coat work in light color; rooms to be wired for electric lights with switch controls (but does not include fixtures) Heating to be either steam or hot water direct radiation and temperature maintained in all rooms at 70 degrees; Toilet room to be fitted complete with three (3) closets, one (1) urinal and two (2) wash basins, all sanitary modern fixtures.

Said lease to be consummated when the above conditions have been fully complied with and building is ready for occupation

Article 81 Vault in Ireland Lodge building

Voted: To indefinitely postpone.

Article 82 Retaining wall, Brookside avenue

Voted: To indefinitely postpone.

Article 83 Maradam street to engine house

Voted: To indefinitely postpone.

Article 84 Establish fuel yard.

Voted: That a Committee of five be nominated to investigate the subject of Art. 84, to report at next annual town meeting, Committee appointed: Frank Spratt, Alonzo Ark, Murray Higgins, C. M. Benson, Frank Nash.

Article 85 Charter for lighting plant.

Voted: That the town take some action to obtain a charter for a municipal lighting plant.
