

Article 86 Revision of building laws.

Voted: That A. M. Lynam, F. H. Savage, G. K. Whitaker, Roy Hauvor, Lester Carter, James Shea and Fred Brewer be a Committee to make recommendations as to the revision of the building laws and to report at some subsequent meeting.

Article 87 Ballot law amended.

Voted: That the legislature be required to amend the Private and Special laws of 1913 relating to Municipal Elections in the Town of Eden, by inserting after the word "surnames" in the 9th line of Section 7 the following: All candidates for selectmen shall be listed alphabetically without any designation as first, second, etc. Previous to balloting for selectmen the voters may determine by majority whether to elect three, five or seven. Without such determination three shall be elected. The three (or if so determined five or seven) having the largest number of votes shall be declared elected.

Article 88 Park Committee.

Voted: That Chas. B. Pines be a park commissioner for twenty years to serve without pay.

Article 89 Street or Road Patrol.

Voted: That the Town establish a street or road patrol, and that the sum of 1500 be set aside from the general repair fund, the sum of 800 from the oil fund, the sum of 500 from permanent road repair fund, the sum of 500 from drainage fund, 100 from sidewalk fund, 100 from street cleaning fund; creating a fund of 3,500 from which fund, a two-ton auto truck be bought, the balance to be expended for labor and supplies under the supervision of the Road Commissioners.

Article 90 Mrs. Loida G. Farmer for injuries.

Voted: To pay Mrs. Loida G. Farmer 20 in settlement for personal injuries received on account of an obstruction in the sidewalk; said amount to be paid from town charges account.

Article 91 Sidewalk at Bulls Cove.

Voted: To indefinitely postpone.

Article 92 Way built by Geo. B. Dorr.

Voted: That the Selectmen be instructed to lay out the way as described in Art. 92 and make their return to the Town Clerk.

Voted: To raise 2,951.29 to pay Mr Geo. B. Dorr the amount he paid out in building this road.


Article 93 Temporary Loan.

Voted: That the Selectmen be given authority to make a temporary loan in anticipation of taxes not exceeding 100,000.

Article 94 Street traffic.

Voted: That Article 1 of the street regulations and rules for driving be so amended that Sections 5, 6, and 7 shall read as follows:

Section 5 a vehicle crossing from one side of the street to the other shall do so—



Section 6. No vehicle unless in an emergency or to allow another vehicle or pedestrian to cross its path shall stop in any public street or highway, except near the right hand curb thereof, so as not to obstruct the crossing.

Section 7. That within one mile of the Post Office, on all roads, no bell, horn, or other device for signaling shall be sounded so as to make a harsh, objectionable or unreasonable noise, except in the case of fire and police department vehicles and ambulances; and provided, further that no operator of any motor vehicle shall at any time, permit any unreasonable amount of smoke to escape from said motor vehicle, nor shall said operator at any time permit said motor vehicle to make any unnecessary noise, by cutting out the Muffler or otherwise.

Article 95. Speed limit

Voted: That the speed limit be 15 miles an hour from Mt Desert Nurseries to the eastern end of the rail on the Bluffs.

Article 62. Resolved:

That the Chair appoint a Committee of three to consult with the road Commissioners in regard to a good roads day to be held about May 15. Chair appointed W. M. Roberts, W. H. Sherman and George B. Dorr.

Article 64. Resolved:

That the voters of the Town heartily appreciate the liberality and public spirit of Mrs. John S. Kennedy in dedicating to perpetual public use the Athletic Field and requested that the Selectmen be instructed to extend to Mrs. Kennedy the Town's cordial and sincere thanks.

Voted: That the Selectmen be instructed to pay B. E. Whitney \$25 for his efficient services as spokesman for the Warrant Committee, said sum to be taken from town charge account.

Voted: That a vote of thanks be extended to the members of the Warrant Committee for their very valuable services to the town.

Voted: That the following named citizens serve as a Warrant Committee for the Municipal year: Frank Spratt, Chas. L. Heland, James Shea, H. F. Emery, L. P. Carter, G. B. Pines, Chas. H. 


